President's Message

Happy New Year 2024! Another holiday season is now in the books with 2024 officially here.

Last year Broadmoor dealt with flooding issues as a result of the most rain we've seen in 30 years. The board of directors and Powerstone spent hundreds of hours and thousands of dollars to address all the requests for service and it looks like we were able to solve many of the issues for the long term. Our on-site staff and all residents need to report when you see clogged drains or any other major pooling of water. Reports should be directed to Powerstone with pictures and addresses. We have made an adjustment to our "mulching policy" to help avoid the ground drains from clogging and making a mess when the rains get intense as well. I'm happy to report that after the first few rainstorms of the current rainy season, we seem to have survived with no major flooding. "So far, so good" as I like to say.

The board is changing our pool service company, which should result in some savings to our pool and spa maintenance costs. Cost is always an important factor with decisions like this, but we will also be monitoring the level of service to ensure this important amenity remains properly maintained.

Repair of the roof tiles that were damaged during fumigation remains in progress and, weather permitting, should be wrapping up by February. We want to thank everyone for your patience with the project and the inconvenience of material storage during this final phase. While small projects will come up throughout the year, it appears that most of the major projects are over for the foreseeable future.

One remaining issue that the board will be thoroughly evaluating will be the condition of our streets. We will

look at different options and review those options and cost estimates sometime later this year.

The elections for your Board of Directors are officially underway, with the elections to be held at our annual meeting of members just before our normal February board meeting on Wednesday, February 21. Please take a few minutes when you receive your ballots in January to return them by mail to Powerstone in the envelopes provided or deposit them in the ballot box at the front guard house. We are all very busy, but your vote matters and it's important that we have your participation.

Speaking of voting and ballots, we are very close to posting the first draft of our "restated" CC&Rs. We are just waiting on a few items from our R1 representative, and a summary of the more important areas being restated or "tweaked" from the original 1977 CC&Rs. Stay tuned, we will send out a blast with the "first draft" for review when it's ready.

Gate security is everyone's responsibility, and we all need to continue to be vigilant about closing the gates behind us and be sure it actually locks. DO NOT let anyone into our community that you don't know has a legitimate reason to be here. If you are unsure, have them walk through the main gate so that our guard staff has a chance to identify any uninvited pedestrian traffic. We have a safe community, but there is a rise in crime outside our gates and locking the gates behind us will help keep us safer.

On behalf of the entire Board of Directors, I want to express our appreciation for the confidence you continue to place in us to manage our little piece of paradise, Broadmoor Huntington Harbour.

O.C. Oil Spill Settlement Checks

In December each Broadmoor record title owner should have received two settlement checks — one from O.C. Oil Spill Settlement (\$496.93) and one from O.C. Oil Spill Shipping Settlement (\$591.97). These checks are the result of settlements of law suits filed regarding the 2021 oil spill in the ocean waters off Huntington Beach against Amplify Energy, whose pipeline was ruptured by anchors dragged by two shipping vessels.

The first check of \$496.92 is net after federal tax withholding of \$156.92 and is reported on the 1099-MISC which accompanied the check. In order to claim credit for that withholding, homeowners will have to report the gross amount of \$653.85 and the \$156.92 withholding on their 2023 federal tax returns. The second check of \$591.97 was not reported on a 1099-MISC filed with the IRS since it is below the \$600 threshold for reporting income. Therefore, that amount does not need to be reported on your return.

Holiday Lights and Decorations

Just a gentle reminder that all holiday lights and decorations must be taken down within one week after the holiday.

Announce Your Guests at Front Gate

The guards have been experiencing an increase in guests and vendors coming to the front guard house and not knowing the address or full name of the residents they are visiting. Please be sure you "call in" any expected guest or vendor before they arrive or schedule them in your GateKey account. If not, your guests will be delayed or possibly denied entry. Thanks for your cooperation.

Lost Mailbox Keys?

If you lose your mailbox keys, do not hire a locksmith to try to drill out the old lock. It is very expensive and difficult if not impossible to do. Instead, order a new Florence CBU mailbox lock (model no. K91910) for about \$26 on Amazon. Then when the postal deliverer is here with the panel door open, simply remove the retaining nut using a 1/2" nut driver and the retaining clip using channel lock pliers, insert the new lock, and reinstall both the retaining clip and retaining nut.
